

Hi Adam,

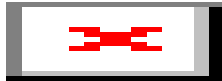
Following your colleagues review of the Travel Plan, please find attached the updated Travel Plan (Document ref: ITB15592-005A).

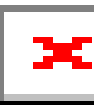
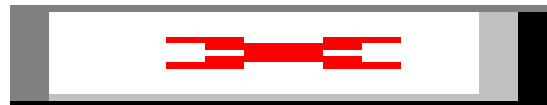

Apologies for the delay in getting back to you on this one, but I was awaiting further info from my TP colleagues.

Further to recent communication on this site, and additionally your queries re the parking layout, I have now received the TP audit from my colleague.

You will note, the parking situation has been raised again including the lack of motorcycle parking, and the reduction from 20 to 19 spaces.

Whilst this Authority has no real concerns over the principle of the development, I would be grateful if you could forward the attached to the developer with a view to getting an amended proposal for further consideration.

Please note that with regard to the Covid-19 situation, for the foreseeable future some Somerset County Council Officers have been redeployed to assist in the Covid-19 mass vaccination programme to provide support and assist frontline workers. Officers within the Highways Development Management Team have been selected for redeployment and as a result, due to staff shortage we are unable to provide a continued full service delivery. Whilst we will attempt to mitigate the impact on our work and timescales as far as is possible, there will be unavoidable consequences in some cases.

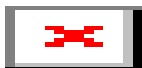
