Thank you for the update on the ground investigation works. As discussed at our meeting yesterday, upon receipt of the report I will upload it onto the website and will advise the parish Council and third parties of its receipt and invite any comments in the usual manner. In addition I will forward the report to the Council's EHO, the EA and Natural England for consideration and comment.

I mentioned that I had received a couple of emails from local residents drawing my attention to the works being carried out at the site. Those emails have been uploaded onto the website and you will note various concerns raised.

In particular the comment that "The grid system plotted by GPS should be at the minimum of 10 meter centres. This would then define geological hazards, soft alluvial materials, contamination and groundwater. The applicants are aware of the contaminated areas consequently the large grid system is being used to avoid these areas."

It would be useful to have the ground investigation team's response to this within the report or in an accompanying letter.

In addition to my email(s) below, we wanted to make you aware of the recent site investigations undertaken at the application site. From review of the public comments received, we understand that many residents have expressed concern that the land south of Bowden Road was formerly used as a burial site during the foot and mouth breakout. Whilst initial site investigation showed no evidence that the site was used a burial ground, Gleeson Land have instructed further investigations in order to provide absolute clarity on the matter.

We are pleased to inform that following the site investigations, we've received a call from our ground investigations team who were on site last week and they have confirmed that they did not find any evidence of the site being used as a burial site. They are in the process of preparing a full report which should be available in the next 2-3 weeks. We will of course send this onto you as soon as we are in receipt of the final copy.
